No.HH-FH-IV(A)-POL-0068/2013 5479 /HE., In exercise of the powers conferred by sub-section (4) of Section 7-C of the Orissa Education Act. 1969 (Orissa Act 15 of 1969), the State Government have been pleased to make the following order to amend the Orissa (Aided College, Aided Junior College and Aided Higher Secondary Schools) Grant-in-Aid Order. 2008 to regulate the payment of GIA in shape of Block Grant to Private Educational Institutions or for any post or to any person employed in such institution namely:-

- 1. (1) This order may be called the Orissa (Aided College, Aided Junior College and Aided Higher Secondary Schools) Grant-in-Aid Amendment Order, 2013.
 - (2) It shall apply to the Non-Govt. Colleges, Junior Colleges and Higher Secondary Schools.
 - (3) It shall come into force on the date of its publication in the Odisha Gazette.
- 2 In the Orissa (Aided Colleges, Aided Junior Colleges and Aided Higher Secondary Schools) Grant-in-Aid Order, 2008 para-16 (1) of the order shall be substituted as follows:-

The teaching and non-teaching employees of the Non-Govt. Educational Institution under Paragraph-9 of GIA Order, 2008 who have joined in their posts on or before 01.06.1998 in Educationally Advanced Districts and on or before 01.06.2000 in Educationally Backward Districts and Women's Educational Institutions established with recognition and affiliation covered

under Grant-in-Aid Order. 2008 shall be paid grant-in-aid in shape of taken grant in the following manner:-

- (a) The eligible employees of these colleges shall be paid 60% of Pay at the initial rate plus Grade Pay in the revised scale of pay of ORSP Rules. 2008.
- (b) The eligible employees, on completion of 08 years from the date of sanction of block grant shall be paid 75% of the Pay at the initial rate plus grade pay in the revised scale of pay of ORSP Rules, 2008.
- (c) The eligible employees, on completion of 11 years from the date of sanction of block grant shall be paid 100% of the Pay at the initial rate plus grade pay in the revised scale of pay of ORSP Rules, 2008."

Order: Ordered that this Notification shall be published in an extraordinary issue of the Odisha Gazette.
